MINUTES OF BOARD OF DIRECTOR'S MEETING - SOUTH COAST ORCHID SUCILLY NOICK

The Meeting was held Saturday, January 19, 1991 at 7:30 p.m. at the home of Do. Phil and Gwen Plocher.

Those present were: Jane and Paul Brecht, George Cooper, Tony Glinskas, Arthur McCann. lames Miller, Dick Nerio, Philip Plocher, Margo Steinman, Gloria Wildharber and Ann and Woody Wilson.

Absent: Charles Bowman (excused), Donald Fraser, Emma Green and Paul Bechtel or another representative for A.O.S. judging.

Dr. Plocher opened the meeting with a welcome to all. Minutes of the meeting held in October were not available. It is believed that Don Fraser did take minutes.

James Miller presented a very comprehensive treasurer's report. He asked for Board approval for several expenditures:

Dick Nerio moved that if lockers are available at Wardlow Park, Jim has approval to pay any rental charged for them. Paul Brecht seconded. Motion approved.

We will try to have the same arrangement for setting up and taking down chairs and tables as in the past. Ann will call Lisa to see if she will continue to do it and we will pay the same amount - \$40.00 per time.

Arthur McCann moved that we approve an amount not to exceed \$75.00 for a speaker who does not provide a plant table. If a speaker wants more money it must come before the Board for a decision beforehand. Woody Wilson seconded. Motion carried.

As a matter of policy, the following statements were agreed upon: Anyone who is in orchid business should not be paid to speak. We should not pay more than two or three speaker per year. Members of the organization will not be paid speaker's fee. People who are in orchid business and bring plants should speak without charge as a form of advertisement. Members of the society should not be taken to dinner before giving a program. People who are in orchid business should not be taken to dinner.

Included in the treasurer's report is a list of future meeting dates - with dates for the second half of the year projected for both Wardlow and Whaley Parks in case constructi at Whaley is not completed in June as expected.

Jim emphasized that our hours at Wardlow are 6:00 to 9:00 p.m.
